THE WEIGHT OF THE PATIBULUM, COMPOUNDED BY EXHAUSTION AND INJURIES, WOULD HAVE SEVERELY TAXED HIS CARDIOVASCULAR AND MUSCULOSKELETAL SYSTEMS. THIS INITIAL STAGE OF SUFFERING LAID THE GROUNDWORK FOR THE MORE SEVERE TRAUMA TO COME.

CHAPTER 2: THE CRUCIFIXION: A MEDICAL PERSPECTIVE ON BRUTAL ROMAN PUNISHMENT

THE CRUCIFIXION ITSELF WAS A METICULOUSLY DESIGNED METHOD OF EXCRUCIATING TORMENT AND DEATH. THE SCOURGING (FLOGGING) INFLICTED BEFORE CRUCIFIXION WAS PARTICULARLY BRUTAL. THIS WOULD HAVE LEFT JESUS VULNERABLE TO INFECTION AND SHOCK. THE CROWN OF THORNS, WHILE SYMBOLICALLY POTENT, ALSO CAUSED SIGNIFICANT TRAUMA TO THE SCALP AND UNDERLYING TISSUES, LEADING TO BLEEDING AND POTENTIAL NEUROLOGICAL DAMAGE. FINALLY, THE NAILING OF THE HANDS AND FEET TO THE CROSS, A PROCESS LIKELY INVOLVING BRUTAL FORCE, CAUSED SEVERE PAIN AND TISSUE DESTRUCTION, COMPROMISING BLOOD FLOW AND NERVE FUNCTION.
