DATA COLLECTION: GATHERING COMPREHENSIVE INFORMATION ABOUT THE PATIENT'S PHYSICAL, PSYCHOLOGICAL, SOCIAL, AND SPIRITUAL STATUS THROUGH OBSERVATION, INTERVIEW, AND EXAMINATION.

DATA ANALYSIS: INTERPRETING THE COLLECTED DATA, IDENTIFYING SIGNIFICANT CUES, AND CLUSTERING RELATED INFORMATION TO FORM A HOLISTIC PICTURE OF THE PATIENT'S CONDITION.

DIAGNOSTIC REASONING: USING CLINICAL JUDGMENT AND CRITICAL THINKING SKILLS TO ARRIVE AT A NURSING DIAGNOSIS THAT ACCURATELY REFLECTS THE PATIENT'S HEALTH PROBLEM.

VERIFICATION: VALIDATING THE CHOSEN DIAGNOSIS WITH THE PATIENT, OTHER HEALTHCARE PROFESSIONALS, AND AVAILABLE RESOURCES.

THE NORTH AMERICAN NURSING DIAGNOSIS ASSOCIATION INTERNATIONAL (NANDA-I) PROVIDES A STANDARDIZED TAXONOMY OF NURSING DIAGNOSES. EACH DIAGNOSIS INCLUDES:

LABEL: A CONCISE STATEMENT OF THE PATIENT'S PROBLEM.

DEFINING CHARACTERISTICS: OBSERVABLE CUES THAT SUPPORT THE PRESENCE OF THE DIAGNOSIS. THESE CAN BE SUBJECTIVE (SYMPTOMS REPORTED BY THE PATIENT) OR OBJECTIVE (SIGNS OBSERVED BY THE NURSE).

RELATED FACTORS: FACTORS THAT CONTRIBUTE TO OR CAUSE THE PROBLEM (ETIOLOGY). UNDERSTANDING RELATED FACTORS IS CRUCIAL FOR PLANNING EFFECTIVE INTERVENTIONS.

RISK FACTORS: FACTORS THAT INCREASE THE LIKELIHOOD OF DEVELOPING A PARTICULAR PROBLEM.

CHAPTER 3: PRIORITIZING NURSING DIAGNOSES AND DEVELOPING COMPREHENSIVE CARE PLANS

PATIENT GOALS: SPECIFIC, MEASURABLE, ACHIEVABLE, RELEVANT, AND TIME-BOUND (SMART) GOALS THAT THE PATIENT WILL ACHIEVE AS A RESULT OF NURSING INTERVENTIONS.

NURSING INTERVENTIONS: SPECIFIC ACTIONS THE NURSE WILL TAKE TO HELP THE PATIENT ACHIEVE THEIR GOALS.

EVALUATION: A PLAN FOR MONITORING THE EFFECTIVENESS OF THE INTERVENTIONS AND MAKING ADJUSTMENTS AS NEEDED.
